**1**. The Memorandum of Intent (MOI) with the KIPF was concluded

#### Date: June 20, 2024 Venue: Korea (Sejong)

The PRI and the KIPF signed the MOI to promote their joint research activities and mutual cooperation.

On June 25, at the Ninth Japan-Korea Finance Ministerial Dialogue was held. This dialogue was attended by Mr. Shunichi Suzuki, Japan's Minister of Finance, and Mr. Sangmok Choi, Korea's Deputy Prime Minister and Minister of Economy and Finance. The Ministers welcomed the signing of the MOI between PRI and KIPF.

# **Research exchanges with think tank in Vietnam** Research Exchange

The PRI has been conducting research exchange activities with National Institute for Finance (NIF), Ministry of Finance, Vietnam.

In November 2024, Mr. Suzuki, Vice President of the PRI attended an international conference hosted by the NIF and delivered a keynote speech. In the same month, Vice President of the NIF and her delegates visited the PRI to learn Japanese experience on the digitalization of tax administration. We are making a close relationship with the NIF based on the Memorandum of Intent (MOI).





## **International Conferences and Symposia**

### Research Exchange

As part of its research and study activities, the PRI holds symposia and conferences usually once or twice a year in order to exchange views with Japanese scholars and economists as well as those from overseas.

Since FY2015, the PRI has been organizing an international conference ("Tokyo Fiscal Forum") in partnership with the IMF and ADBI. The 9th Tokyo Fiscal Forum (Strengthening Public Finance by Collecting and Spending Transparently and Efficiently ) was held in June 2024.

In addition, in FY2023, the ASEAN+3 Financial Think-tank Network (AFTN) was established with the aim of contributing to the regional macroeconomic and financial resilience and stability of the ASEAN+3 region, and the PRI is also participating.

# Visiting Scholar Program

#### Research Exchange

The objective of the Visiting Scholar Program is to provide an opportunity for government officials or researchers mainly from developing countries to study fiscal and financial issues as part of Japan's ODA program.

The PRI invites researchers from developing countries with specialized knowledge of the current economic conditions in developing countries, or who wish to study Japanese fiscal and economic policies.

Furthermore, the PRI invites officials from ministries of finance and central banks in developing countries, or those from developed countries with specialized knowledge of the current economic conditions of developing countries. The visiting scholars are required to submit a research paper and give a presentation at a workshop. Their research papers have been utilized as important resources for the PRI projects.
